

KINESIS IDENTITY SECURITY SYSTEM INC. ("KINESIS")

END USER LICENSE AGREEMENT FOR URQUi ("Software")

IMPORTANT - READ BEFORE COPYING, INSTALLING OR USING. You may install and use the Software on any telephone owned by you and used for your personal use. You may not copy, modify, rent, sell, distribute or transfer any part of the Software except as provided in this Agreement, and you agree to prevent unauthorized copying of the Software. You may not rent, lease, lend, redistribute or sublicense the Software. 6. Termination. URQUi may terminate this Agreement at any time if you violate its terms. Upon termination, you will immediately cease using and destroy the Software.

7. Applicable Laws and General Provisions. This license is governed by and shall be interpreted in accordance with the laws of British Columbia and Canada, excluding British Columbias principles of conflict of laws and the United Nations Convention on Contracts for the International Sale of Goods, which is also expressly excluded. All disputes and claims of whatever nature shall be adjudicated by a court of competent jurisdiction in British Columbia. You may not export the Software in violation of applicable export laws and regulations. URQUi is not obligated under any other agreements unless they are in writing and signed by an authorized representative of URQUi. This License constitutes the entire agreement between the parties with respect to the use of the Software and supersedes all prior or contemporaneous understandings regarding such subject matter.
